To all contractors who employ Ironworkers in the jurisdiction of **Ironworkers Local Union #498**:  
Please be advised that effective **June 1, 2017 through May 31, 2018**, wage rates will be as follows:

Hourly wage for:	Regular	Time and a half	Double Time
Journeyman	\$38.33	\$57.50	\$76.66
Foreman with 2 men or less	\$40.25	\$60.38	\$80.50
Foreman with 3 men or more	\$42.16	\$63.24	\$84.32
General Foreman	\$44.08	\$66.12	\$88.16

The guidelines for overtime pay are:

If you are working a National Maintenance Agreement, metal building construction or some Project Labor Agreements you are to pay time and a half for overtime. If it is new construction overtime is double time.

**Apprentice Rates are as follows:**


